Purpose of the Position

This post is opened in the context of the Junior Professional Officer (JPO) scheme sponsored by the Government of the Netherlands and is addressed exclusively to candidates from developing countries (see the criteria in the website of the Netherlands Ministry of Foreign Affairs below).

Under the supervision of the Chief, Child Protection, you will support capacity building of government institutions at national and sub national levels in the areas of social and legal protection.

Key Expected Results

- Support the availability of accurate, complete and up to date information required for effective Child Protection programme and project design, implementation, management, monitoring and evaluation.
- Enhance project efficiency through implementation follow up, including monitoring UNICEF inputs.

 Undertakes ongoing visits to UNICEF project sites, monitors UNICEF inputs.
- Drafts relevant sections of reports required for donors, management, annual reports. Assist in the drafting of Country Programme Recommendation and other project documentation, assuring accuracy and consistency with established rules, regulations and action plans.
- Compile Child Protection project implementation training and orientation materials to promote knowledge sharing with donors, media etc.
- Team with local Government counterparts to exchange information on Child Protection.

Qualifications of Successful Candidate

Education: University degree in one of the relevant areas- International Law, Human Rights, or Social Science. A combination of a university degree at the BSc or BA level and a minimum three years of experience is considered equivalent to a university degree at the MSc or MA level.

Work experience: Bachelor's degree and 3 years of relevant experience or Master's degree and preferably 2 years of



relevant professional work experience on human rights issues, child protection. Working in emergency situations in developing countries is an asset.

Candidates will less than two years relevant experience and who have earned a university degree at the MSc or MA level will be appointed at the P-1 level.
